



## Abbeyfield Burnaby

### SPONSORS

It is desirable that each resident at Abbeyfield House Burnaby be supported by TWO sponsors who each agree to assume responsibility for the resident in the event of sickness or infirmity beyond the scope of the care that Abbeyfield Burnaby is able to provide.

Sponsors acknowledge that this may mean providing personal care at Abbeyfield House or engaging professionals to do this on their behalf. Payment for these services and for the transfer of the resident to a hospital or care facility, if needed, is their responsibility if the resident is unable to handle finances at any time.

Before a person can be considered for residency at Abbeyfield House Burnaby, the Society requires a signed "Agreement by Sponsors". The agreement form is on the next page. The signed (blue) "Agreement by Sponsors" must be submitted with the (pink) "Application for Residency".

The Sponsor of a person who is applying for residence at Abbeyfield Burnaby is encouraged to participate in the life of the House as a volunteer and as a member of the Abbeyfield House St. Margaret of Scotland Society. Membership of the Society costs \$10 a year. Members are entitled to vote at the Annual General Meeting when matters of importance to the operations of the House and the well-being of residents are raised.

## AGREEMENT BY SPONSORS

We understand that if, at any time in the future, the Society decides that the person for whom we are Sponsors needs more care than the Society provides by way of support for independent living, the Society may ask her/him to leave Abbeyfield House Burnaby and we agree that if the Society asks her/him to leave for that reason we will make all arrangements necessary for her/him to leave the House within thirty days of receiving such request.
